ASA Governance Overview

Legal Structure

Company Limited by Guarantee

The Australasian Sonographers Association Ltd (ASA) is a company limited by guarantee.

This particular type of public company is well suited to not-for-profit membership organisations like the ASA. Instead of issuing shares, ASA has members, who enjoy the rights and privileges of membership.

The company's liability is limited, meaning that if the company is dissolved, the personal liability of each of its members is limited to \$20.00.

Registered Charity

ASA is also a register charity, registered with the Australian Charities and Not-for-profits Commission.

Objects

ASA's objects, set out in its Constitution, are to advance the health of the public and to advance the education of individuals performing ultrasound by undertaking the following activities:

- (a) promoting and advocating for the advancement of the sonography profession;
- (b) supporting and disseminating research that contributes to the sonography profession's body of knowledge;
- (c) positioning sonographers as the experts and principal providers of diagnostic medical ultrasound;
- (d) contributing to the quality and standards of sonography practice by developing recommendations for sonographers and the sonography industry;
- (e) engaging with Government and other health care providers to improve the quality and accessibility of sonography services and the future supply of sonographers in the workforce;
- (f) facilitating professional development opportunities through conferences, meetings, workshops and online activities;
- (g) offering a broad range of opportunities for sonographers to advance their professional knowledge;
- (h) advancing the education of those performing ultrasound and other people involved in sonography, including in less developed communities for improved health outcomes; and
- (i) undertaking other actions or activities necessary, incidental or conducive to advance these objects.

Governance Arrangements

Constitution

Like all public companies, ASA has a Constitution, which sets out how the company is managed.

The Constitution, which was updated in June 2025, provides for:

Different classes of membership, with different membership rights

The main class of membership, and the only type with voting rights, is Accredited Medical Sonographer Members.

Different Types of Directors

ASA can have up to 7 General Directors who must be Accredited Medical Sonographer Members and who are elected by the membership, and three External Directors, who are appointed by the Board of Directors.

If there are fewer than 7 General Directors, the Board can appoint a Casual Director who can stay on the Board until the next annual general meeting. A Casual Director must be an Accredited Medical Sonographer Member.

Annual General Meetings

ASA has to hold annual general meetings at which the members can approve ASA's report and accounts for the previous financial year, and ask questions to the directors about the performance and direction of the company.

The Members also have other rights set out in the Corporations Act 2001.

Board of Directors

The Constitution gives the Board responsibility for managing ASA's business, other than any powers reserved for the membership.

The Board of Directors are responsible for the efficient and effective management of ASA. Their main responsibilities are:

- appointment of the CEO and review of the CEO's performance
- approving ASA's strategic plans and objectives
- approving ASA's operating plans
- ensuring that the ASA has robust financial systems and controls in place, approving ASA's annual budgets and assessing financial performance
- · approval of significant governance, board and organisational policies
- setting ASA's risk framework, and reviewing strategic risks and other risks outside tolerances
- ensuring that ASA complies with all its regulatory requirements, including work health and safety requirements

setting and promoting a positive culture

Immediately after each annual general meeting, the Board appoints the President and the Vice-president of ASA.

To assist with its governance, the Board has developed a Board Charter, a Board Code of Conduct and a Probity Policy.

Board Committees

The Board operates two Board Committees, each with written Terms of Reference approved by the Board:

The Finance Audit and Risk Committee (FRAC)

This Committee has responsibility for detailed examination of all ASA's financial activities, including oversight of the annual external audit and its investments.

Governance Nominations and Remuneration Committee (GNRC)

This Committee's remit is to advise the Board on all matters relating to ASA's governance.

Company Secretary

ASA's governance functions are fully supported by a professional Company Secretary.

The Role of the Chief Executive Officer

The Board has delegated some of its powers and authorities to the CEO.

The CEO is responsible for the day-to-day operations of ASA, including:

- preparation of financial budgets and reports
- employment and performance of all staff members
- organisation of member services, including continuing professional development
- organisation of the annual scientific conference

The President and the CEO work closely together to ensure the smooth running of ASA.
